Sir/Madam,

In inviting a reference to the subject and letters cited above, it is observed from the data
uploaded by various Higher Secondary Schools/Colleges in SAMs e-Space under CC TV link, that the
CC TV installation status of few examination centres haven't been uploaded till date. Either the said
H.S. Schools/Colleges haven't installed CCTV in their respective Centres or haven't uploaded the
data although CC TV have been installed in their Examination Centres. All such Examination Centres
are required to install CC TV in their Centres, if not installed yet, and upload the CC TV installation
status in SAMs e-Space under CCTV link by 25.02.2020 positively.

The negligence of such H.S. Schools/Colleges in this regard has been viewed seriously by the
Council and the Government. Hence, failure to comply to the above instructions will invoke CHSE to
initiate appropriate steps including cancellation of the Examination Centre and tagging it with
nearby Examination Centre and forwarding the names of such defaulting H.S. Schools/Colleges to
the Govt. for appropriate disciplinary action as deemed fit and proper.

This is to be treated as most urgent.
