**Remittance of Examination fees by H.S. Schools**

01. Ex- Regular Students :- The H.S. School will retain ₹ 50/- for theory and ₹ 20/- for practical subject & ₹ 20/- for project evaluation work and remit the rest amount ₹ 470/- only along with the late fine amount ₹ 350/- per examinee to the Council.
02. Regular students :- (a) Out of the total examination fees collected i.e. ₹ 520/- towards Theory Papers, the H.S. School will retain ₹ 40/- for centre expenses and remit the balance amount of ₹ 480/- along with the late fine amount of ₹ 350/- per examinee.



- (b) The H.S. School will collect @ ₹ 40/- towards Practical Examinations/Project evaluation works per paper per student and retain @ ₹ 30/- for conduct of Practical examinations / Project evaluation works and remit the rest amount @ ₹ 10/- per paper per examinee to the Council.

The other form fill-up criteria will remain unchanged.

**N.B: - This is the last opportunity to the defaulting Ex-Regular and Regular students and under no circumstances the date of filling-up of forms for Ex-Regular and Regular students will be extended further.**


