# 01. <u>FEE STRUCTURE FOR ARTS/COMMERCE/SCIENCE/VOCATIONAL &</u> <u>DISTANCE EDUCATION CANDIDATES(REGULAR/ EX-REGULAR):</u>

i	For appearing in a non-practical Subject	Rs.520/- (Rupees Five Hundred Twenty) only
ii	For Appearing in a Practical/Project paper (except Biology)	Rs. 560/- (Rupees Five Hundred Sixty) only
iii	For Appearing in Biology subject	Rs. 600/- (Rupees Six Hundred ) only

2. Candidates who have paid additional Centre Charge at the time of Annual H.S. Examination, 2024 shall also have to pay additional Centre Charge (@ ₹ 50/- only per candidate) if they fill up Examination forms for Instant Examination, 2024.

3. Candidates with bench mark disabilities are eligible for Examination fee waiver Rs.165/- (Examinations fees) plus the Practical/Project Examination fees @ Rs.40/- per paper and fees for memorandum of marks of Rs.100/

4. Submission of the following documents by the candidate is compulsory in the H.S. School at the time of filling up of forms :

- (i) Self attestedXerox copy of the downloaded Mark Sheet of AHS Examination 2024
- (ii) One passport size photograph.

5.Documentsto be submitted by the H.S. Schools in the Council. (Head Office/ZonalOffice as the case may be):

# It is mandatory to submit the following documents:

- (i) Annexure-2
- (ii) SB Collect receipt
- (iii) Xerox copy of Mark Sheet showing Instant Examination eligibility.
- N.B. 1. The H.S. Schools will retain ₹30/- only per paper for conduct of Practical Examination and remit the rest amount @ Rs. 10/- Per Paper Per student to the Council.

2. Out of the Examination fees collected for Theory paper @ Rs.520/- per student, a sum of Rs.40/- will be retained by the H.S. School for centre expenses and balance amount @ Rs. 480/- per examinee be remitted to the Council online through SB Collect by logging into www.onlinesbi.com.

3. In the case a H.S. School is not declared as a centre for Instant Examination-2024 and is tagged to another Examination Centre, and then the tagged H.S. School should handover such collected amount to the H.S. School to which it is tagged. The Examination centre shall have to receive the money from the tagged college with proper receipt and submit U.C. to the Council within one month from the date completion of H.S. Instant Examination-2024 (both Theory and Practical).

(i)- A Regular/Ex-Regular Candidate of ARTS, COMMERCE, SCIENCE &VOCATIONAL STREAMS along with Distance Education<u>who has secured pass mark in aggregate (210 marks)</u>, but has failed in one compulsory/Elective/Trade paper in AHS Examination 2024 is eligible to appear the Instant Examination-2024 only in that single Compulsory/Elective/Trade subject.

(ii)- Further, a candidate <u>who has appeared in the AHS Examination-2024 as a</u> <u>Compartmental Candidate only in one paper</u>, but has failed in that paper is eligible to appear the Instant Examination-2024 only in that Failed paper.

(iii)- A candidate whose result has been withheld/cancelled for mass malpractice or has been booked under malpractice, shall not be eligible for Instant Examination -2024.

(iv)- In case of a paper having both theory and practical/project component, following actions are to be taken.

Condition		Action to be taken	
1-	Failed/Absent in practical/project component but passed in theory component.	Candidate has to appear in practical / project component only.	
2-	Failed/Absent in theory but passed in practical/ project.	Candidate has to appear only in theory paper . There is no need of appearing in practical	
3-	Failed/Absent in both theory and practical/project component of a paper .	The candidate has to appear Examination for both theory and practical/project component of a paper.	

(v)- The candidate will appear practical/project Examination at his/her own college.

N.B. 1. Under no circumstance, Annexure-2, SB Collect receipts etc. of the candidates appearing at INSTANT EXAMINATION, 2024 shall be received after the scheduled dates.
