NOTIFICATION

No. EG-I-11/2021/<u>4821</u>/CHSE/In continuation to the instructions issued under Notification No. 4727 dt. 14.09.2021, of CHSE along with the notified Programme of Annual H.S. (Special) Examination, 2021, the following clarifications are hereby issued for information and necessary action of all concerned in pursuance to the decision of the Examination Committee in their meeting held on dt.18.09.2021.

Examinees registered for Annual H.S. (Special) Examination, 2021 will be given the option to appear in the Examination on the following premise.

- 1. Appearance of the examinees of all the streams in English and MIL papers (except Alternative English) is mandatory for all non-compartmental examinees.
- 2. Marks secured in English will be awarded in Alternative English paper if the examinee has Alternative English paper in his/her subject combination.
- 3. In Arts stream, there will be no examination in Language Optional papers. Marks secured by a candidate in MIL will be awarded in Language Optional paper irrespective of the Language Optional. Marks awarded in the Language Optional paper by this principle will be taken as marks secured in an Elective Paper. However, an examinee will be required to appear in at least two elective papers of his/her subject combination excluding Language Optional paper if examination is being conducted in these papers.
- 4. Out of the four elective papers in Arts, Science and Commerce streams, examinees will be required to appear in at least two elective papers (Theory Component) of their choice. Marks will be awarded in the remaining elective papers basing on the average score of the appeared elective papers.
- 5. For the **examinees of Vocational streams**: Out of three BFC papers, appearance in at least two BFC papers (Theory Component) is compulsory. Score in the remaining BFC paper, if any, and in the Trade Papers (Theory) will be awarded basing on the average score of the BFC Papers.
- 6. i) In case of compartmental examinees: Appearance in English and MIL (except Alternative English) is compulsory, if they are enrolled for the same.
 - ii) If a compartmental examinee is enrolled for examination in two or more elective papers (Arts, Science & Commerce)/BFC (Vocational) papers, appearance in at

least two elective papers/BFC Papers is mandatory. Scores in the remaining elective paper(s)/BFC paper/Trade papers (Theory Component) will be awarded on the basis of the average score of elective papers/BFC papers appeared by the examinees.

- iii) If a compartmental examinee is enrolled with only one elective paper/BFC paper, appearance in that paper is mandatory. Score in the Trade paper, if any, will be awarded basing on the score of the BFC paper appeared.
- However, if an examinee appears in all elective papers of Arts/ Science/Commerce Streams/all BFC papers of Vocational Streams as registered for the Annual H.S. (Special) Examination, 2021, the actual scores obtained by the examinee in the appeared papers will be taken for result processing.
- 8. If any examinee has registered to appear in the Annual H.S. (Special) Examination, 2021 and fails to appear in the said examination, his/her earlier result of Annual H.S. Examination, 2021 will remain valid.

For Ex-Regular examinees, whose results have been withheld for non appearance in Annual H.S. Examination (Theory/Both Theory & Practical) conducted by CHSE prior to 2021, shall be decided solely on the basis of their performance in the Annual H.S. (Special) Examination, 2021, following the procedure as mentioned above.

However, if an examinee appears in at least one or more papers in Annual H.S. (Special) Examination, 2021 and remains absent in the remaining papers then his/her result of Annual H.S. Examination, 2021 will be cancelled and his/her results will be published on the basis of his/her performance in Annual H.S. (Special) Examination, 2021.

9. For the Practical/Project Component: Those students, who have already passed in the Practical/Project Component of the paper in Annual H.S. Examination, 2021 shall not submit the Practical Paper/Project Report for evaluation in Annual H.S. (Special) Examination, 2021 once again. Marks obtained by them in the Practical/Project Papers will be carried forward to Annual H.S. (Special) Examination, 2021. Those students who had failed to submit the Practical Records/Project Reports for evaluation in Annual H.S. Examination, 2021, and failed in the Practical/Project papers are required to submit the same in their respective H.S. Schools/ Colleges between 22.09.2021 and 29.09.2021. Their Practical Records/ Project Reports will be assessed by the concerned H.S. School as per the Alternative Assessment scheme notified vide Notification No. 2526 dt.18.06.2021,

The relevant clauses of instruction issued vide Notification No. 4727 dt. 14.09.2021 are modified to the above extent.
