

One of its immediate opportunities on the portal is regarding the **Viksit Bharat Young Leaders Dialogue**, i.e., the reimagined National Youth Festival, 2025. A significant highlight of the festival is the **Viksit Bharat Challenge**, comprising a quiz, an essay writing segment and development of a vision deck. Youth selected through this multi-tiered challenge will get an unprecedented opportunity to present their vision of Viksit Bharat directly to the Hon'ble Prime Minister during the two day national level dialogue to be held in New Delhi on 11th and 12th Jan 2025.
