





Quotation without tender fee and EMD or received after due date & time shall be summarily rejected. Council shall not be responsible for any postal delay.
4. Quotationers are required to submit self-attested copy of GST Registration Certificate, Income Tax, Permanent Account Number (PAN), Aadhar Card in the prescribed pro forma failing which quotation paper shall not be considered.
5. The successful bidders will have to lift the materials within 7 (Seven) days from the date of issue of Sale order after depositing the full offered amount failing which the earnest money will stand forfeited and the material will be sold to next highest responsive bidder.
