### **REMUNERATION TO CHIEF EXAMINER**

#### **THEORY (CHIEF EXAMINER)**

1. An "Examining chief examiner" shall get Rs 300/- if assisted by one or two Asst. Examiner and Rs 600/- if assisted by Three to Five Asst. Examiner.  
(Note: All the above Chief examiner will be paid on the basis of actual no. of examiners.)
2. A Non-examining Chief Examiner having more than Six (6) Asst. Examiner shall get Rs 1500/-.

#### **TABULATOR/SCRUTINISERS**

1. A Scrutinizer (appointed for the theory paper) shall get Rs 2.00 per script.

#### **MISCELLANEOUS/ INCIDENTAL EXPENSES**

All other incidental charges in connection with the examination are ordinarily permissible on production of vouchers subject to a maximum of Rs 40/- in case of Non-Examining Chief Examiner, Rs 20/- in case of Examining Chief Examiner and single Examiner and Rs 20/- in case of Asst. Examiner. In absence of voucher, a maximum of Rs 20/- will be paid based on a certificate given by the examiners (all types) to the effect that the amount was actually spent.
